



POLICIES

Each group is responsible to adhere to the policies of Millions of Monicas. This is not optional.

1. Any individual or group not adhering to the Millions of Monicas Policies or Leadership Expectations shall not have the right to use the Millions of Monicas name or logo, nor represent the ministry in any manner.
2. Millions of Monicas is not a lobbying organization, regardless of how worthy the cause. Under no circumstances should the Millions of Monicas name be used in conjunction with any outside issues.
3. Confidentiality brings integrity to our ministry; therefore, all prayer requests must be held in the strictest confidence.
4. Millions of Monicas are not to hold their services anywhere but on the parish grounds, in particular it should be in the church or chapel.
5. Millions of Monicas prayer groups are not to solicit prayer requests nor place a prayer request in the back of church or any public facility.
6. Unauthorized use of the Millions of Monicas name or logo is prohibited. It is the trademark of Millions of Monicas and requires the express, written permission of Millions of Monicas National Leadership Team.
7. Millions of Monicas rosters are for ministry use only. Under no circumstances are they to be used by, loaned to or shared with any other individual, organization, business or outside group.
8. No form of advertisement may be placed inside or on any Millions of Monicas materials.
9. Millions of Monicas groups are not to engage in gossip or any conversation of a critical nature.
10. Millions of Monicas exclusively believes in biblical marriage as the covenant relationship between one man and one woman.
11. Millions of Monicas groups are specifically for women only.
12. We do not counsel women.
13. Any leader who receives a request for an interview or press inquiry, must first contact Jane VanHouten at JaneVH@millionsofmonicas.com for prior approval from the Millions of Monicas National Leadership Team. Helpful guidance from the Team will be provided for the leader to follow.
